## General conditions for stall hire at the Albion Park Show

1. Stall holders must have their own public liability cover of \$20M. A copy of the Policy must be provided to the Show prior to the Exhibition

Hobbyist Stall Holders do not require evidence of insurance if they meet the definition of hobbyist. Hobbyist cannot have an ABN and must earn less than \$20k a year from their stall holding activity. **NOTE Hobbyist stall holders must sign Declaration at the foot of this application form**

2. Market Stalls are approximately 3m x 3m.
3. Stall holders will be directed to their site on the day.
4. Stallholders, where appropriate, shall ensure that it is licensed or registered to carry out the activity listed on their registration.
5. Power is not supplied to sites.
6. Market stalls to be ready to trade for a 8.30am start; sites will be available from 7:00am.
7. All stall holder vehicles to be removed from site by 8:30am. Stall holders will be directed to an appropriate parking area.
8. Stall holders to provide their own tables and equipment.
9. Stallholder participation will be at the discretion of the organising committee.
10. The stallholder shall ensure that its site or sites are left in a clean and tidy condition at the end of the event and all rubbish is removed.

12. Two trade pass entries are included in the price and will be sent prior to the Show.
